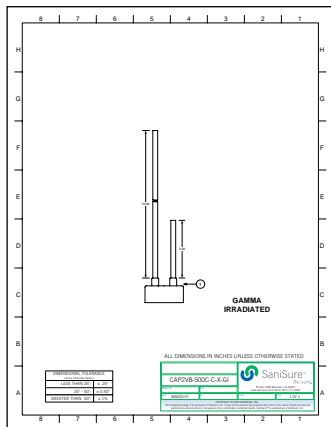

- 1 - 2 PORT Cap2v8 Cap W/ 1/8" ID x 1/4" OD TUBING
  - Vent Line - 3.0" OAL
  - Transfer Line – 10.0" OAL

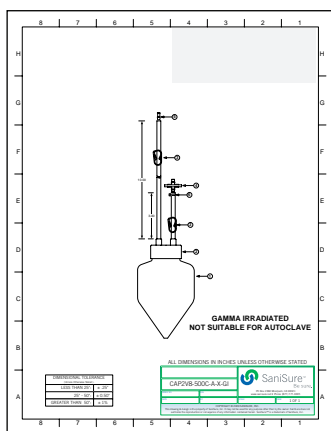
- Transfer of biopharmaceutical products and reagents in a closed system

- Autoclave – 15 psi @ 134°C, 60 min
  - C-Flex® and PharMed® formulations only, PVC not recommended
  - Irradiated assemblies can not be autoclaved
- Gamma Radiation – 25 kGy to 50 kGy

- 1 - 500 mL CENTRIFUGE TUBE, POLYSTYRENE
- 1 - 2 PORT Cap2v8 Cap W/ 1/8" ID x 1/4" OD TUBING
  - Vent Line - 3.0" OAL

- 1 - 25 mm 0.2µm Hydrophobic Filter
